Learning about "stalking horse offers", the value of a real estate agent's assistance in the auction process, cooperation with Chapter 7 and Chapter 11 bankruptcy trustees when liquidating property, and the role of attorneys hired as special counsel **(1 Hr. CLE General)**

Cryptocurrency and Blockchain Technology Panel. Presented by Ido Alexander of AlignX Law, Steven M. At the end of the discussion, the attendees will rotate but each Bankruptcy Judge will remain at their table to discuss the same topic with the next group of attendees. This enables all the attendees to interact individually with each Judge. Hear topics from our local judges about the potential impacts of AI on bankruptcy practices, plan injunctions, streamlining Chapter 13 cases, Chapter 11 Pre-filing Considerations, The Alex Jones dilemma – attempting to revoke a subchapter V election, professional disclosures and guarding fees against disgorgement and *Bartenwerfer v. Buckley*. **(1 Hr. Ethics/Professionalism CLE General)**
